Remarks

1. Each course will be limited to 25 participants only. Signing up for the course is therefore on a first-come, first-served basis.
2. Instruction language will be in Putonghua, Cantonese, and English. Lecture notes will be mainly in English.
3. Course Fee is non-refundable. Once the application is accepted, the course fees will not be refunded.
4. All applicants must attend at least 80% of the lessons of the course; otherwise, the participant will be disqualified from both the Written Examination and the Field Examination.
5. Certificates will be awarded to participants who succeed in passing the examination and attend in practical training sessions for not less than 16 hours.
6. The practical training must be completed within a period of twelve months of the examination date.
7. Participants who completed the practical training can apply for the Judge & Official Registration under the Hong Kong China Federation of Roller Sports and Skateboarding Limited.
8. If the applicant cannot provide sufficient documents or a valid cheque within the application period, the HKCFS&S reserves the right to reject the application.
9. HKCFS&S reserves the right to request the applicant to provide proof of qualifications/experience in roller skating.
10. All applicants must arrange their own personal accident insurance.
11. HKCFS&S reserves the right to accept or reject the application.
12. HKCFS&S reserves the right to make any change in the course, and the decision should be final. HKCFS&S will announce the change to the participants as early as possible.
13. In case of rescheduling, notification will be given.
